2026-2027 Class Fees and Policies

For your convenience, registration is done online via **Studio Pro**. If you need assistance, e-mail us at scb@carolinaballet.com or call 919-747-8459. Initial registration and placement are done by participant's age. Students will be evaluated during the first week of classes to ensure proper placement. Tuition will be adjusted accordingly if the student's level changes.

- A **non-refundable**, annual registration fee of \$50.00 **per family** is required upon enrollment.
- Tuition is not prorated on a weekly basis. We encourage students to register on the 1st of the month. If a student registers mid-month, the full tuition amount is due on the day of registration.
- Tuition is based on the total yearly cost for classes. Tuition may be paid in full upon registration; or tuition payments are set as monthly automatic recurring payments through the parent portal by bank draft or by credit or debit card on file. On the monthly payment plan, your annual total is divided into 10 equal monthly payments beginning August 1st, 2026 through May 1st, 2027. Tuition payments are due on the 1st of the month. If the tuition auto-draft falls on a holiday or weekend, then payment will be processed on the next available business day. Tuition is **non-refundable and non-transferable**
- Online auto-draft payments can be made by linking a bank account or by Visa, MasterCard, Discover or American Express. A late fee of \$25.00 will be added to accounts that are 10 days past due. If payment is still not satisfied by the 1st of the following month, that student will not be permitted to participate in classes until all tuition payments are up to date.
- Checks should be made payable to Carolina Ballet, Inc. A \$25.00 fee will be charged for any returned checks.
- Federal holiday and school closures do not alter monthly tuition. Tuition will not be reduced due to family vacation, sickness or other activities.
- Class transfers require approval from the Chairman of Faculty, a written 30-day notice, and are limited to one transfer per student per year.
- Withdrawal from a class due to a serious injury must be accompanied by a physician's note in lieu of a 30-day notice. All other withdrawal requests must be made in writing and requires a 30-day notice. Billing to your child's account will continue until written notice is received and during the 30-day notice period.

- In an effort to reduce disruption to our regularly scheduled classes, we will not allow students to make up for missed classes during the 2026-2027 school year. No refunds will be issued due to absences.
- A late pick-up fee of \$15 will be applied if a child is not picked up within the first 10 minutes after the scheduled dismissal time. An additional fee of \$1 per minute will be charged for every minute thereafter. The exact time of arrival will be documented ONLY when parents notify the superintendent or administrative associate upon arrival by coming inside to do so. We understand that unforeseen circumstances may arise, and we will always do our best to accommodate special circumstances. If that is the case, please email scb@carolinaballet.com. This is only held for extremely extenuating circumstances. This policy has been put in place to ensure the safety and well-being of all our students and to help maintain the smooth operation of our program. Your cooperation in adhering to this policy is greatly appreciated.
- The Boy's Ballet Scholarship only covers recipients' Ballet Technique, Men's and Partnering classes. All other required classes or optional additional classes, based on level, are not covered by this scholarship.
- Financial Aid applications will open **May 1st, 2026** and close **July 31st, 2026**. If you apply for Financial Aid, your first month's tuition will be paused pending your award decision. If aid is granted, it will be applied retroactively across the remaining auto-drafts for the school year. Any families applying for Financial Aid must also be fully enrolled in order to be evaluated for an award.
